## Overview of the U.S. Labor History (every 5 years)

1492 Christopher Columbus arrives and so begins the colonization of the Americas, and with it, the widespread genocide of the indigenous people of the Americas.

1619 The first shipload of 20 indentured African slaves arrives in Jamestown, Virginia.

1676 A group of white indentured servants and black slaves revolt against the colonial government of Virginia in what became known as Bacon's Rebellion.

1718 Large-scale immigration from Scotland and Ireland begins, with most of the immigrants settling in New England, Maryland, and Pennsylvania.

1776 The Continental Congress ratifies the Declaration of Independence in which the original 13 colonies of the United States declare, among other things, that "all men are created equal."
